EWG'S SUSTAINABLE AGRICULTURE PROGRAM WORKS TO BUILD A TRULY SUSTAINABLE FOOD PRODUCTION SYSTEM THAT SUPPORTS FAMILY FARMS, PROTECTS PUBLIC HEALTH, AND IMPROVES THE ENVIRONMENT. WE TOOK A TWO-PRONG APPROACH TO THIS GOAL IN 2013: FIRST, BY FIGHTING FOR A FARM BILL THAT PROMOTES SUSTAINABLE AGRICULTURE VIA SUBSIDY REFORM; SECOND, BY USING STATE-OF-THE-ART REMOTE SENSING AND GEOSPATIAL ANALYSIS TO TELL COMPELLING STORIES ABOUT THE DAMAGE INFLICTED BY INDUSTRIAL AGRICULTURE ON OUR LANDSCAPES AND WATERSHEDS. WE ACHIEVED A MAJOR VICTORY IN THE SUBSIDY REFORM FIGHT AS BOTH THE HOUSE AND SENATE VERSIONS OF THE FARM BILL FINALLY ENDED DIRECT PAYMENTS. EWG'S FARM SUBSIDY DATABASE AND RELENTLESS CAMPAIGNING MADE IT CLEAR THAT DIRECT PAYMENTS ARE NO LONGER POLITICALLY SUSTAINABLE. EWG WAS THE FIRST NGO TO PUSH HARD FOR CROP
