I have told Ms Scranton that we are working on a response to her question. I contacted Charlotte Christin from OC, twice, and she responded after the second time, to let me know that I would hear back from Latasha. I have heard nothing yet. I have contacted in the past Jennifer Thomas, specifically because the issue of formaldehyde use in cosmetics needed to be addressed, at least from the labeling perspective, and in order to close out the investigation. In the absence of a close out, we cannot issue a consumer alert. In fact the idea of a consumer alert was recently dismissed, in favor of an update to our webpage, so that the media might not get alerted. The bottom line is that we had not received from the manufacturer, a satisfactory warning statement in response to the Brazilian blowout warning letter. At this point, we have to address the email below, and I am not sure what the office/center/agency wishes to do to respond. Please advise. Thank you.
