

2009-2012 Farm Bill Spending for Nutrition and Food Assistance: US and California

Farm bill funding for nutrition and food assistance steadily increased from 2009 to 2012 as more people relied on aid to meet their food needs during a difficult economy. SNAP accounts for 98 percent of farm bill nutrition funding, which increased from \$49.2 billion in 2009 to \$75 billion in 2012. Some of the increase was the result of additional funding provided in the American Recovery and Reinvestment Act of 2009. That boost has now expired and SNAP spending will likely decline. The number of individuals served by SNAP increased from 37.7 million in 2009 to 46.6 million in 2012, when one in seven Americans relied on the program. The average per-person benefit is \$133, or \$4.40 per day. California receives 9.5 percent of the farm bill's nutrition and food assistance funding. In October 2013, 4.2 million California residents received SNAP assistance.
