EWG's meat and dairy label decoder helps consumers identify food companies and farmers that raise livestock on pastures instead of factory farms, and that treat these animals humanely. Pasture-based livestock production has benefits for the environment when compared to factory farms.

MANY CERTIFICATIONS ON MEAT AND DAIRY LABELS ARE MORE RELIABLE THAN OTHERS, SO KNOWING THE DIFFERENCE MATTERS.

This certification verifies animals are raised on a pasture or range with the highest welfare standards in the U.S. EWG recommends choosing products with this certification.



This certification ensures

This certification is a tiered animal welfare program that evaluates and rates farming practices across six levels, from Step 1 (basic welfare) to Step 5+ (highest welfare). EWG recommends picking products at Steps 4, 5 or 5+.

Some of these labels might be familiar, like "free range" and "grass fed." Others you might see for the first time, such as Animal Welfare Approved. But trying to decipher everything on a food label can be overwhelming – EWG is here to help.

Use our updated food label decoder to compare and contrast information found on labels at the supermarket for beef, chicken, dairy, eggs, pork and turkey. It's a simple and quick way to make more informed decisions about what you're buying and eating.
